If the **SuperDyma® CRP** steel cladding (installed and maintained in accordance with the specific guidelines, terms and conditions attached) fails to perform as warranted due to a defect in the material, then at the sole discretion of NS BlueScope (Thailand) Limited ("NSBST") the cladding will either be repaired, resupplied (but not installation), or compensation provided pro-rata in terms of actual performance versus warranted performance, and amount of time remaining in warranty. No liability shall be accepted for any consequential loss or damages attributable to the failure.

This is to certify that representatives or agents of **< Customer Name >** have inspected the installed cladding, and ascertained (by best endeavours) that;

- The cladding is manufactured from prime quality **SuperDyma® CRP < Antibacterial, Antistatic > steel** (branded on reverse) ;-

TERMS AND CONDITIONS

This warranty is subject to the following terms and conditions;

1. This warranty applies only to **SuperDyma® CRP** which has a base metal thickness of 0.3mm (or greater) and issued as the skins of a sandwich panel.
2. The product must be installed in accordance with the manufacturer's published fixing recommendations, current at the time of installation, including BlueScope Steel's Technical Bulletins CTB-12, TB-8 and TB-31.
3. Only neutral cure sealants are to be applied to panel joints. Slip joints and channels must be inspected annually and sealant replaced where necessary,
4. All external installations must be greater than 1km from marine or industrial environments.
5. All components fixed to the panels must be either manufactured from COLOBOND® steel or ZINCZLUME® steel, aluminium, zinc, or other BlueScope Steel approved material in accordance with BlueScope Steel recommendations (as per Technical Bulletin TB-8).
6. The BlueScope Steel applied paint finish, must not be scratched, abraded, over-painted, treated with chemicals, damaged in any way, or coated with an incompatible material.
7. All fasteners used in conjunction **SuperDyma® CRP** are to be in accordance with BlueScope Steel recommendations see corrosion Technical Bulletin, CTB-12 Fasteners must be inspected on a regular basis and immediately replaced if they exhibit signs of corrosion failure.
8. All areas must be kept washed and clean, as corrosion arising in unwashed areas is not covered by this warranty. Cleaning chemicals must only be used in concentrations and contact durations as recommend by the chemical supplier. In any event, the concentration of the cleaning solution should not exceed 5%. Furthermore, high pressure water should not exceed 400psi (2760kPa) water pressure.
9. This warranty is not applicable to heavy industrial environments including, without limitation, chemical processing or storage, aluminium processing, fertilizer processing and storage, pulp and paper mills, or any similar facility which uses or is otherwise exposed to corrosive chemicals or environment.
10. Perforations partly or wholly due to the following causes are not covered by this warranty:
 - a) Failure to seal all joints during installation or whilst in service, to prevent moisture ingress into the panel system.
 - b) Mechanical, chemical, corrosion or other damage sustained during transport,
 - c) Attack from chemical agents, fumes, liquids or solids stored in the cool room.
 - d) Contact with, mortar, bitumen, soils, ashes, fertilizers or other moisture retaining substances.
 - e) Immersion as a result of flood or substandard site drainage.
 - f) Areas in metallic contact with lead or copper or subject to the run-off from lead or copper pipes.
 - g) Failure to remove debris and/or failure to provide free drainage of water from all surfaces of the product.
 - h) Deterioration of the sheet caused by contact with green, wet or treated timbers.
 - i) Installations subject to unusually corrosive environments at any time in the future.
 - j) Acts of God and falling objects, external force, explosions, fire, riots, civil commotions, acts of war, radiation, harmful gases or fumes, chemicals or foreign substances in the air or atmosphere, acts of terrorism, global warming, flooding and political disturbances including but not limited to uprisings and protests
 - k) Any loss or damage resulting from non-compliance with the terms and conditions of this warranty.
11. Any defects must be informed to NSBST in writing within 30 days of the date NSBST in its sole discretion believes such defect should reasonably have been found given each individual circumstance.

Should perforation occur in less than 15 years, BlueScope Steel's liability shall be limited exclusively to replacement or repair of the affected portion of the material supplied by BlueScope Steel to the manufacturer ("Warranted Product"), as follows:

Limitation of liability

To the extent permitted by law, BlueScope Steel's liability is limited to, at BlueScope Steel's sole discretion:

- a) the replacement or repair of the Warranted Product;
- b) the cost of the replacement or repair of the Warranted Product.

To the extent permitted by law:

- a) All implied warranties, representations, terms and conditions relating to the supply of and use of the Product are excluded.
- b) BlueScope Steel shall not be liable for any labour costs associated with the installation or removal of the Warranted Product or the fixing of replacement panels; or Injury to persons, or damage to property or any other direct or indirect (including consequential) loss arising from the use of the product.

NS BlueScope (Thailand) Limited extends this warranty solely to the Manufacturer.
